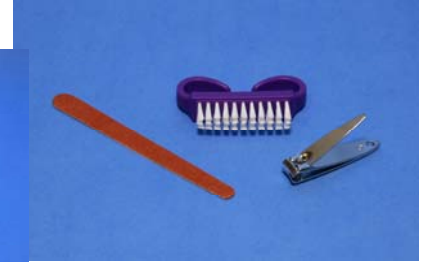



TERMS AND CONDITIONS

1. In addition to the information required by Section 7 of the Industrial Welfare Commission Order, records shall be kept on file, covering the period of this permit, showing:
 - (a) The nature of each handicapped worker's disability, including, where appropriate, medical reports and examinations;
 - (b) Each worker's piece-work production, if applicable;
 - (c) Records of time studies made to establish piece-rates, if applicable.
2. A roster shall be kept, showing name of client, date of hire, program of enrollment, and beginning rate of pay. The roster shall cover the period of this permit.
3. Piece rates shall not be less than the piece rates paid nonhandicapped employees engaged in the same work in the vicinity in regular commercial industry maintaining approved labor standards.
4. A copy of this permit shall be posted at each location where clients will be employed.
5. No provision of this permit shall excuse non-compliance with any other Federal or State law establishing higher standards.
6. All other provisions of the Industrial Welfare Commission Orders shall be observed.

Congratulations, your firm has been registered with our office as a recognized nonprofit organization. Your firm is entitled to benefits under the Prompt Payment Act procedures as set forth in California Government Code, Title 1, Section 927 et seq.

The Prompt Payment Act encourages state agencies pay properly submitted, undisputed invoices of recognized nonprofit organizations in a timely manner. Prompt payment is reinforced by adding interest penalties for late payment.

When the invoice is not paid by the **date required in the contract** or if a payment date is not specified in the contract, **within 45 days of receipt of the invoice**, the Act requires state agencies to automatically calculate and pay registered nonprofit organizations a penalty of 0.25% (one quarter of one percent) of the amount due times the number of days late. The 45 days includes 30 days for the awarding department and 15 days for the State Controller.

The Prompt Payment Program includes the use of a rubber stamp to alert state agencies of a firm's registered nonprofit status. The rubber stamp contains the California Great Seal and a firm's reference number (REF#)

Ordering a rubber stamp

Rubber stamps are available in two styles:

Traditional rubber stamp	\$15
Pre-inked rubber stamp	\$25

To purchase a rubber stamp, return the enclosed "Prompt Payment Stamp Request" form to the OSBCR with your check or money order made payable to the **Department of General Services**. Along with your stamp, you will receive instructions for its use and further information pertaining to the Prompt Payment Act.

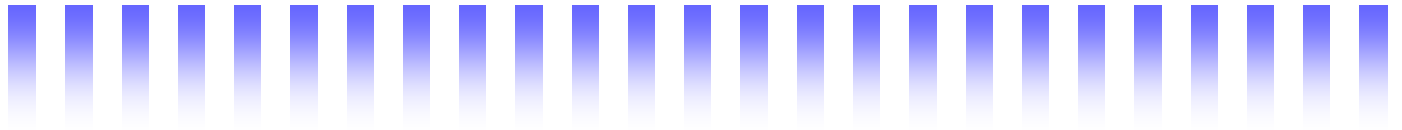
